PROCEDURAL ORDER

BY THE COMMISSION:

On January 28, 2002, Qwest Corporation ("Qwest") filed tariff revisions to give its customers the option of instituting a freeze of their local exchange provider.

On January 31, 2002, Cox Arizona Telcom, LLC ("Cox") filed a Motion for Suspension and for Hearing. Cox requests the Commission conduct an evidentiary hearing to fully examine the propriety of the local service freeze and to determine if the tariff should be approved.

On February 4, 2002, WorldCom, Inc., on behalf of its regulated subsidiaries, ("WCom") and Time Warner Telecom of Arizona, LLC ("TWTA") filed separate Joinders in Cox's Motion.

On February 19, 2002, the Commission granted intervention to WCom and TWTA.

On February 26, 2002, the Commission accepted Staff's recommendation to suspend this tariff until May 27, 2002. The Commissioners directed the matter to the Hearing Division.

IT IS THEREFORE ORDERED a Procedural Conference, for the purpose of establishing procedures for this matter, shall commence on March 11, 2002, at 11:00 a.m. at the Commission's offices, 1200 W. Washington, Phoenix, Arizona.
