PROCEDURAL ORDER

8 **BY THE COMMISSION:**

10 On February 26, 2002, the Arizona Corporation Commission ("Commission") suspended this
11 tariff until May 27, 2002, and directed the matter to the Hearing Division for an evidentiary hearing.
12 Pursuant to our Procedural Order dated March 25, 2002, which set a schedule for pre-filed testimony
13 and a hearing date, Staff was ordered to present the matter to the Commission at its regularly
14 scheduled April Open Meeting with a recommendation to continue the suspension of this matter.
15 Staff requests additional time to prepare a recommended order for the Commission. Staff's request is
16 reasonable as the Commission has another regularly scheduled Open Meeting in May prior to the
17 expiration of the current suspension

18 IT IS THEREFORE ORDERED that Staff shall present the matter to the Commission at its
19 regularly scheduled May Open Meeting with a recommendation that the suspension should be
20 extended a sufficient amount of time to permit an evidentiary hearing and the preparation of an
21 Recommended Opinion and Order.

22 IT IS FURTHER ORDERED that all other terms of the March 25, 2002 Procedural Order
23 shall remain in effect.

24 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
25 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
