INSUFFICIENCY LETTER #2

Dear Mr. Sallquist:

In reference to the above mentioned application filed on February 8, 2006, and the supporting documents filed on April 28, 2006, this letter is to inform you that the application still has not met the sufficiency requirements as outlined in the Arizona Administrative Code. The deficiency is:

1. In response to Item No. 3 of the February 8, 2006 Insufficiency letter, Johnson Utilities, L.L.C. provided only one request for service for Section 7, Township 2 South, Range 8 East. According to the Pinal County Assessor Record, approximately 533 acres of Section 7 belongs to the Church of Jesus Christ of Later Day Saints ("LDS") while the rest belongs to Zimmerman Land, LLC. Please provide the request for service from Zimmerman Land, LLC or an evidence that the property owner has given its consent for Johnson Utilities, L.L.C. to extend service to its property.

Staff would like to use this opportunity to bring the following to your attention:

- Pursuant to the Arizona Administrative Code ("A.A.C.") R-14-2-610(C)(4), the time-frame for administrative completeness review shall be suspended from the time the notice of deficiency is issued until staff determines that the application is complete. Upon meeting sufficiency requirements, the Commission has 150 calendar days for its substantive review. This includes conducting a hearing and preparing Opinion and Order to present to the Commission at an Open Meeting.


