

**SUMMARY OF THE TESTIMONY OF JASON BETHKE
ON BEHALF OF THE TOWN OF CAREFREE**

The Town submitted an affidavit of Jason Bethke (“Bethke”) on March 9, 2006 that the Town intended to be treated as direct testimony. Bethke’s affidavit incorporated a report prepared under Bethke’s direction and review regarding the operations of Black Mountain Sewer Corporation and odors arising from those operations. The report is known as the “Odor Control Review and Recommendations” (the “Report”) and was commissioned by the Town and prepared by Carter Burgess. At the time the Report was prepared, Bethke was an employee of Carter Burgess.
