On June 6, 2003, Gold Canyon Sewer Company ("Gold Canyon") filed a Notice of Filing Revised Tariff for a Reduction in the Commodity Rate for Effluent Sales in the above-referenced matter. Upon the recommendation of its Staff, the Arizona Corporation Commission ("Commission") suspended the tariff revision for a period of 120 days through October 29, 2003. See Decision No. 66029 (July 3, 2003).

Gold Canyon respectfully requests that the Commission extend the original 120-day suspension, made pursuant to A.R.S. § 40-250.B (through October 29, 2003) to December 16, 2003. Such extension would still allow for the above-referenced matter to be resolved through the administrative process within the six (6) month limitation imposed by A.R.S. § 40-250.B.

Gold Canyon has conferred with Staff regarding this request, and Staff has stated no objections.


