RE: STAFF UPDATE - IN THE MATTER OF THE APPLICATION OF NETWORK SERVICE BILLING, INC. FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE RESOLD LONG DISTANCE TELECOMMUNICATIONS SERVICES (DOCKET NO. T-04319A-05-0440)

On June 17, 2005, Network Service Billing, Inc. ("NSBI") filed an application for a Certificate of Convenience and Necessity ("CC&N") to provide resold long distance telecommunications services in the State of Arizona. On May 25, 2006, the Administrative Law Judge issued a Procedural Order which stated that no filing had been made since the Application was filed and that Staff should make a filing updating the Commission on the status of this matter and indicate whether the matter should be administratively closed.

On May 31, 2006, Staff received an e-mailed inquiry from Christa L. Fallin of Lance J.M. Steinhart, P.C. who represents NSBI. In the e-mail, Ms. Fallin indicated that she had received the Procedural Order and inquired about who to talk to in order to make sure this matter is not closed. In addition, Staff was informed that the Affidavit of Publication had been mailed via 2-day FedEx and that we should receive it on June 1, 2006.

On June 15, Staff was informed by Ms. Fallin that NSBI had submitted the Affidavit of Publication but that it had been returned. It appears that although the applicant filed the Affidavit using the docket number that had been assigned to the original application, that company number is incorrect. It had previously been assigned to Network Billing Systems, LLC. The Procedural Order in this matter also references the company number that is assigned to Network Billing Systems, LLC. The correct docket number for this matter is T-04319A-05-0440.

Given the correspondence from Ms. Fallin who represents NBSI, Staff recommends that this matter not be administratively closed.
