

NOTICE OF APPLICATION FOR A CERTIFICATE OF CONVENIENCE AND NECESSITY TO PROVIDE COMPETITIVE RESOLD INTEREXCHANGE TELECOMMUNICATIONS SERVICES BY NETWORK SERVICE BILLING, INC.

NETWORK SERVICE BILLING, INC. R14-3-105, except that all motions to intervene must be filed within twenty (20) days of the date of this notice. You may have the right to intervene in the proceeding, or you may make a statement for the record.
