PROCEDURAL ORDER

BY THE COMMISSION:

On February 15, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 67576 which granted Beardsley Water Company ("Beardsley") a permanent rate increase. Decision No. 67576 also directed Beardsley to develop a master water plan and submit such plan to the Director of the Utilities Division within one year of the effective date of the Decision.

On March 8, 2006, First National Management, Inc. ("First National"), the agent for Beardsley Water Company, filed a request for a 90-day extension¹ to file the required master water plan. First National states that there are a number of major developments either proposed or in progress in Beardsley's service area and that the development activity has affected the timing of preparing a master plan.

By Procedural Order issued March 23, 2006, the requested extension was granted.

On June 15, 2006, First National requested an additional 30 day extension, until July 15, 2006, to file the required master water plan. First National stated that filing delay was necessitated by the large amount of development in progress and the health of the individual retained to prepare Beardsley's water system master plan.

IT IS THEREFORE ORDERED that the requested extension is granted and Beardsley Water Company shall develop a master water plan and file the master plan, as a compliance item in this

¹ Although the extension request indicates that the master plan was due by March 15, 2006, the effective date of the Decision was February 15, 2005 and the plan was therefore due no later than *February* 15, 2006.

1 docket, by no later than July 15, 2006.

2 IT IS FURTHER ORDERED that in all other respects Decision No. 67576 shall remain in full
3 force and effect.


