**NOTIFICATION OF INTERVENTION**

**BY THE COMMISSION:**

12 On October 25, 2002, WorldCom, Inc. on behalf of its regulated subsidiaries, ("WorldCom")  
13 filed an Application for Intervention in the above-captioned matter. WorldCom states that it is  
14 affected by the proposed sale of Dex, Inc. because it entered into interconnection agreements with  
15 Qwest Corporation ("Qwest"), the provisions of which require Qwest to provide certain directory  
16 listing services.

17 On November 4, 2002, Qwest filed a Response to WorldCom's Application, and objected to  
18 WorldCom's intervention. Qwest argues that WorldCom has not demonstrated that it is directly and  
19 substantially affected by the proceeding, as the application for approval of the sale of Dex does not  
20 raise any issues relating to the provision of wholesale services by Qwest. In the alternative, Qwest  
21 argues that if the Commission is inclined to permit WorldCom's intervention, it should limit such  
22 intervention to the sole issue of the impact of the Dex sale on WorldCom's interconnection  
23 agreements with the regulated entity, Qwest.


24 On November 13, 2002, WorldCom filed a Reply in Support of the Application to Intervene.  
25 WorldCom argues its interconnection agreements contain provisions directly related to directory  
26 publishing vis-à-vis Dex, which contemplate Qwest using its affiliated relationship with Dex.

27 WorldCom has interconnection agreements with Qwest that require Qwest to provide certain  
28 directory listing services. Such agreements could be affected by the proposed sale of Dex, Inc.

1 Consequently, WorldCom has demonstrated a sufficient interest to support its intervention in the  
2 above-captioned matter. Such intervention shall be limited, however, to issues affecting the impact  
3 of the proposed sale of Dex on WorldCom's interconnection agreements with Qwest.

4 IT IS THEREFORE ORDERED that WorldCom's Application to Intervene is granted,  
5 subject to the limitation discussed hereinabove.


