



12 The Residential Utility Consumer Office ("RUCO") respectfully submits the following
13 comment in response to Staff's Request For a Procedural Order. RUCO requests that the
14 proposed hearing date be changed as both its attorneys have conflicts on the day Staff
15 proposes to commence the hearing. The hearing in Citizen's application to adjust its current
16 PPFAC (Docket No. E-01032C-00-0751) is currently scheduled to start on June 24, 2003.
17 Arizona Water Company's application for a rate increase (Docket No. W-01445A-02-0619) is
