PROCEDURAL ORDER

**BY THE COMMISSION:**

On March 19, 2003, the Residential Utility Consumer Office ("RUCO") filed public and confidential versions of the direct testimony of Ben Johnson, PH.D. On page 46, lines 18-21 of the public version of the testimony, RUCO inadvertently included information based on confidential, trade secret data supplied by Qwest.

On April 3, 2003, Qwest Corporation ("Qwest") and RUCO filed a Joint Motion For Substitute And Release Of Public Testimony Of Ben Johnson, Ph.D. ("Motion"). Qwest and RUCO request an Order releasing the March 19, 2003 testimony and replacing it with the testimony supplied with their April 3, 2003 Motion.

No party objected to the substitution.

IT IS THEREFORE ORDERED that Docket Control shall substitute page 46 of the Ben Johnson testimony filed on April 3, 2003, for page 46 of the March 19, 2003 public version of Dr. Johnson's testimony.


