**PROCEDURAL ORDER GRANTING
ADMISSION PRO HAC VICE**

BY THE COMMISSION:

On August 6, 2002, Citizens Communications Company, Arizona Gas Division ("Citizens"), filed with the Arizona Corporation Commission ("Commission") an application for increase in rates.

On August 21, 2002, pursuant to Rule 33(D) of the Rules of the Supreme Court, Susan Mikes Doherty of the New York law firm of Huber, Lawrence & Abell filed an Application to Appear in this case *Pro Hac Vice*. The Application listed Deborah R. Scott, Associate General Counsel for Citizens, as the designated member of the State Bar with whom communications can be made and upon whom papers shall be served. Attached to the Application was a Consent to designation signed by Ms. Scott.

Ms. Doherty states that she is in good standing in the State of New York and that she is not currently suspended or disbarred in any court. The Applicant further states that she has not applied in the past two years to appear as counsel *Pro Hac Vice* before the Arizona Commission, or in any court in Arizona. No party has submitted opposition to the Application filed by Ms. Doherty.

In the discretion of the Commission, Susan Mikes Doherty shall be permitted to appear and participate in the above-captioned matter.
