Dear John LaPorta:

I am writing you regarding the proposed 70.93% rate increase for which the Aubrey Water Company has applied. I am the sole administrator for a school of 160 students grades K-12. Our school budget is very tight. Last year our total water bill was \$10,492. The proposed increase would drive our bills to \$17,934 if our usage stays the same (we project an increase in usage for the coming year). Our budget is already set for the 2006-2007 school year.

I understand the need for an increase; however, if that increase could be spread out over two or three years that would certainly help us absorb the expense into an already tightly stretched budget. For the last four years we have worked hard to lower the school tax rate and still deliver quality experiences to our students and pay our employees a decent wage. Unforeseen expenses such as this threaten our very existence.
