NOTICE OF FILING

On June 23, 2006 Staff filed a Motion to Compel the production of the federal and state tax returns for the years 2003, 2004 and 2005 for Perkins Mountain Water Company and Perkins Mountain Utilities Company ("the Applicants") and five affiliated companies: Sagebrush Enterprises, Inc., Sedora Holdings, LLC, Desert Community, Inc., American Land Management, LLC, and Rhodes Homes Arizona, LLC, as well as the federal and state income tax returns for Mr. Jim Rhodes for the years 2003, 2004 and 2005.

On July 6, 2006, the Applicants filed a Response to Staff's Motion to Compel and Request for a Protective Order to prevent disclosure of such highly confidential tax returns.

On July 12, 2006, the Administrative Law Judge ("ALJ") in this matter was advised on a teleconference with the parties that the Applicants and Staff are working toward a resolution of the discovery dispute that is satisfactory to both parties. The parties
