Dear Corporation Commission Staff:

The Second Set of Data Requests sent to Adelphia Telecommunications, Inc. (“Adelphia”) on June 6, 2006, included two inquiries about the practices of Telecom Management, Inc. d/b/a Pioneer Telephone (“Pioneer”) (see JFB2-9 and JFB2-10). Since Pioneer filed the joint petition regarding the sale of Adelphia’s long distance services to Pioneer, and since Adelphia will cease to conduct its business operations on July 31, 2006 as a result of a bankruptcy sale, Adelphia asks that the Arizona Corporation Commission request this information directly from Pioneer.

Adelphia does not have the legal means to require Pioneer to offer the requested information to Adelphia, especially within a certain time period. Adelphia will have very limited staff and resources available to close down its business operations after July 31, 2006. Adelphia has forwarded the original and second Data Requests to Pioneer’s counsel, but it may not be possible for Adelphia to follow up with Pioneer or prepare the response containing the information from Pioneer. For these reasons, Adelphia asks that the Arizona Corporation Commission request this information directly from Pioneer.
