
*In Decision No. 67941, the Commission ordered all Arizona ETCs to file a report by June 21, 2006, discussing each ETC's outreach programs in conformity with the new Federal Communications Commission ("FCC") guidelines and their impact on Lifeline and Link-up subscribership levels. By Procedural Order dated June 26, 2006, this filing deadline was subsequently extended until July 21, 2006. The FCC's guidelines recommend ETCs utilize*

## OUTREACH PROGRAM REPORT

### MIDVALE TELEPHONE EXCHANGE, INC.

Midvale Telephone Exchange serves five areas in Arizona all characterized as rural and none representing a significant non-English speaking population. The areas serviced include (1) Cascabel, near Benson; (2) Young, near Payson; (3) Silverbell, near Eloy; (4) Granite Mountain, near Scottsdale; and (5) Millsite, near Prescott.

Each year Midvale publishes notices in local newspapers notifying customers of our rates and the availability of low-income programs, namely Lifeline and Link-up (see attached samples). Midvale has increased efforts to reach customers who might qualify through a number of strategies, as outlined below.

1. Department of Economic Security. Midvale contacted DES and asked for a report showing information regarding anyone receiving aid through the qualifying programs for people who live in our service areas. Midvale was informed that DES only provides that information for Qwest and that they had no way of providing us that information for our customers.
2. Web-based. Midvale has developed a web-page accessible to anyone which includes information and application forms for Lifeline and Link-up programs.
3. Personnel. Midvale has conducted trainings with all customer service staff and field technicians to help identify customers who might benefit from either Lifeline or Link-up.
4. Community outreach. Midvale has contacted local churches and senior citizen centers making presentations and providing information on Lifeline and Link-up to share with their constituents.


