Pursuant to Decision No. 67941, all Arizona Eligible Telecommunications Carriers were required to file a report with the Commission by June 21, 2006, which discusses each carrier's outreach program utilizing the new Federal Communications Commission's guidelines on outreach programs and their impact on Lifeline and Link-up subscribership levels. Copper Valley Telephone and Valley Telephone Cooperative, Inc. (the "Companies") received a 30-day extension of time (until July 21, 2006) to file the report. The Companies contacted Commission Staff and the Hearing Division on July 21, 2006 to request an additional one week extension to file the report. Commission Staff does not oppose the additional extension. Accordingly, the Companies respectfully request a 7-day extension of time until July 28, 2006 to file the required report regarding their outreach programs.
