STAFF'S REQUEST TO  
MODIFY PROCEDURAL  
SCHEDULE

The Commission's Utilities Division staff ("Staff") respectfully requests that the procedural deadlines in this case be modified from the current schedule regarding the dates for filing of direct testimony and rebuttal testimony. Staff requests that the Staff and Intervenors' direct testimony deadline be extended from June 20, 2001 to June 26, 2001 by 4:00 p.m., and that the Company's rebuttal testimony deadline be extended from June 18, 2001 to July 24, 2001 by 4:00 p.m.

Staff has contacted counsel for Arizona Water Company and counsel for the Residential Consumer Office regarding this request, and is authorized to state that those parties do not oppose Staff's request, with the condition that no other existing procedural dates in this matter be changed.

Staff therefore respectfully requests that a Procedural Order be issued extending the deadline for the filing of direct testimony to June 26, 2001 by 4:00 p.m., and extending the deadline for the filing of rebuttal testimony to July 24, 2001 by 4:00 p.m.
