PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On June 20, 2001, the Arizona Corporation Commission's Utilities Division Staff ("Staff")
11 filed a request for a modification of the January 23, 2001 Procedural Schedule to allow additional
12 time for the filing of testimony. Staff Counsel contacted counsel for Arizona Water Company and
13 the Residential Utility Consumer Office and those parties do not oppose Staff's request.

14 IT IS THEREFORE ORDERED that the Staff and Intervenors' direct testimony shall be filed
15 by 4 p.m. on June 26, 2001 and Arizona Water Company's rebuttal testimony shall be due by 4 p.m.
16 on July 24, 2001.

17 IT IS FURTHER ORDERED that all other dates and deadlines from the January 23, 2001
18 Procedural Order, as modified by the January 29, 2001 Procedural Order, shall remain in full force
19 and effect.

20 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend, or waive
21 any portion of this Procedural Order either by subsequent Procedural Order or by ruling at hearing.
