NOTIFICATION OF
INTERVENTION

BY THE COMMISSION:

On July 28, 2006, Arizona Public Service Company ("APS") filed a motion to intervene in the above-captioned matter. APS is a public service corporation that provides electric service within Arizona. APS seeks intervention because this matter raises issues concerning the regulatory status of wholesale competition in the state, the resolution of which could have a direct impact on APS.

On August 18, 2006, Southwest Energy Efficiency Project ("SWEEP") and Western Resource Advocates ("WRA") filed Motions to Intervene in this docket. SWEEP is a non-profit public interest organization promoting greater energy efficiency in the southwest, including Arizona. WRA is a regional environmental law and policy center serving the Rocky Mountain and Desert Southwest states.

No party objected to any of the requests to intervene. Intervention by APS, SWEEP and WRA will not unduly broaden the issues nor delay the proceeding.

IT IS THEREFORE ORDERED that the **requests to intervene** of APS, SWEEP and WRA are **granted**.


