PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 On June 29, 1998, Preferred Carrier Services, Inc. d/b/a Phones for All ("Applicant") filed
11 with Docket Control of the Arizona Corporation Commission ("Commission") an application for a
12 Certificate of Convenience and Necessity ("Certificate") to provide local exchange services as a
13 reseller within the State of Arizona.

14 Pursuant to A.A.C. R14-2-1104 and R14-2-1105, Applicant is required to publish notice of its
15 filing in all counties where services is to be provided.

16 On July 20, 1998, Applicant filed Affidavits of Publication in Coconino, Maricopa, Pima and
17 Yuma Counties. In a letter dated May 14, 2001, Applicant indicates it intends to provide service in
18 only those four counties.

19 On August 20, 1999, the Commission's Utilities Division Staff ("Staff") filed its Staff Report
20 in this matter. In part, the Staff Report recommended that Applicant procure a performance bond or
21 escrow account in an amount to cover 60 days revenue from its customers and any prepayments or
22 deposits collected from its customers. However, since that time a number of Commission policies
23 and procedures have changed sufficiently to warrant the filing of an amended Staff Report to ensure
24 compliance with those new policies and procedures as well as to obtain Applicant's updated financial
25 information.

26 Pursuant to A.R.S. § 40-282, the Commission may act on an application for a Certificate to
27 provide resold telecommunications services without a hearing, or with a hearing if one is requested
28 by any party.

1 Pursuant to A.A.C. R14-2-1106 and R14-2-1108, the Commission now issues this Procedural
2 Order to govern the preparation and conduct of this proceeding.

3 IT IS FURTHER ORDERED that Staff shall file an amended Staff Report on or before
4 December 1, 2001.

5 IT IS FURTHER ORDERED that intervention shall be in accordance with A.A.C. R14-2-105,
6 except that all motions to intervene must be filed on or before December 1, 2001.


7 IT IS FURTHER ORDERED that Preferred Carrier Services, Inc. d/b/a Phones for All shall
8 file any exceptions to the Staff Report or request a hearing before January 4, 2002.

9 IT IS FURTHER ORDERED that the failure of Preferred Carrier Services, Inc. d/b/a Phones
10 for All to comply with any or all of the Ordering paragraphs set forth in this Procedural Order within
11 the timeframes specified may result in the denial of Preferred Carrier Services, Inc. d/b/a Phones for
12 All's application.

13 IT IS FURTHER ORDERED that the time periods specified herein shall not be extended
14 pursuant to Rule 6(a) or (e) of the Arizona Rules of Civil Procedure.

15 IT IS FURTHER ORDERED that the Presiding Officer may rescind, alter, amend or waive
16 any portion of this Procedural Order by subsequent Procedural Order or by ruling at hearing.
