PROCEDURAL ORDER

BY THE COMMISSION:

On June 21, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 67941 which adopted the new Federal Communications Commission's guidelines on addressing changes to the Lifeline and Link-up programs in Arizona for all Eligible Telecommunications Carriers with conditions.

On July 24, 2006, Copper Valley Telephone and Valley Telephone Cooperative, Inc. requested a 7-day extension of time to file the report required in Decision No. 67941 regarding the outreach program and stating that Staff had no objection to this request.

IT IS THEREFORE ORDERED that the Copper Valley Telephone and Valley Telephone Cooperative, Inc. shall file the report regarding their outreach programs on or before July 28, 2006.
