On Monday, July 24, 2006, Staff from the Utilities Division of the Arizona Corporation Commission issued a request for written clarification of the status of Utility Source, L.L.C. (file number L-1005592-7). Per that request, Corporations Division investigated the entity and has concluded the following:

Utility Source, L.L.C. formed on October 12, 2001. It has supplied Corporations Division with the documents necessary to exist and do business in the state of Arizona. The Corporations Division presently has no actions pending against Utility Source, L.L.C., nor is it planning any in the foreseeable future. There are currently no outstanding Corporations Division issues regarding this entity that would prevent or hinder Utility Source, L.L.C.'s ability to operate in Arizona.
