Response to Staff's Fourth Set of Data Requests

Ladies and Gentlemen:

On behalf of AmeriVon LLC ("AmeriVon"), transmitted herewith is an original plus thirteen (13) copies of its responses to Staff's Fourth Set of Data Requests, dated June 23, 2006.

STF 4.1 Staff research indicates a company named Amerivon, LLC that is headquartered at 29219 Canwood Street, Suite 240, Agoura Hills, California 91301. Please explain:

- (1) if AmeriVon's information in (A-2) has changed since AmeriVon filed its application,
- (2) if AmeriVon has an affiliate at the above address, or
- (3) if AmeriVon, as represented in its application to the Arizona Corporation Commission, and the company referenced above are unrelated.

Response: Amerivon LLC headquarters is located at 800 Southwood Blvd, Suite 212, Incline Village, NV 89451. Amerivon Holdings LLC, an 80% shareholder of Amerivon LLC had an office at 29219 Canwood Street, Suite 240, Agoura Hills, CA 91301 when Amerivon LLC was first established in 2003. At the time, AmeriVon LLC was dormant.

Amerivon Holdings LLC no longer maintains an office 29219 Canwood Street, Agoura Hills. Amerivon LLC moved its headquarters to Incline Village, NV, when its operations went active in August of 2005.

The address listed in response to A-2 is therefore current and accurate.

STF 4.2 Information at www.amerivon.com indicates a different CEO/President than stated in (A-4) of AmeriVon's application. If company contact information in (A-4) has changed since AmeriVon filed its application, please provide updated information and explain the reasons for such changes.

Response: In its Application, AmeriVon LLC listed its Internet website address as www.amerivon.com in its response to A-2. This website is currently in the process of being transitioned to AmeriVon Holdings LLC, an 80% owner of AmeriVon LLC. Because it is still in transition, some of the information on the website is not current and still reflects AmeriVon LLC. The remaining inconsistencies are in the process of being cleaned up. Nonetheless, the information regarding management pertains to AmeriVon Holdings LLC, not the Applicant, AmeriVon LLC.


Since filing its Application with the Commission in September 2005, AmeriVon LLC has refined and focused its operations. As AmeriVon prepares for the launch of its services, it adopted the service mark, AmeriVon Communications, and is transitioning services sold under the mark to a new website: <http://www.amerivoncomm.com/>.
