SECOND INSUFFICIENCY LETTER

Dear Mr. Geake:

The application of Trico Electric Cooperative ("TRICO") for approval of an extension of a Certificate of Convenience and Necessity, Docket No. E-01461A-04-0393 has not met the sufficiency requirements as outlined in the Arizona Administrative Code ("A.A.C.").

To correct the deficiencies, please provide the following information:

1. A copy of TRICO's Revised Long Range Construction Work Plan 2004-2023.
2. Projected annual load development in the Willow Springs Ranch Area including the schedule for completion of all the units in the subdivision.
3. Documentation from TRICO that the request for service from the developer is still valid.
4. TRICO's updated economic impact analysis of providing service to the Applicant, as discussed in our meeting on July 10, 2006.
5. Record of TRICO's "Deferred Maintenance" for 2004 and 2005 in accordance with the RUS Form.
6. A copy of the latest technical study, such as power flow study, prepared by AEPCO/SWTRNSCO on behalf of TRICO showing the transmission infrastructure needed to serve TRICO's future system load requirements, including the Willow Springs Ranch area.
