PROCEDURAL ORDER

BY THE COMMISSION:

On April 5, 2006, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity for Hearing ("Notice") against David Lee McMillan and Polly P. McMillan, Husband and Wife (collectively "Respondents"), in which the Division alleged that the Respondents committed multiple violations of the Arizona Securities Act ("Act") in connection with the offer and sale of securities in the form of investment contracts.

Respondents were duly served with copies of the Notice.

On May 12, 2005, Respondent Polly P. McMillan filed a request for hearing.

On June 1, 2006, the Commission issued Decision No. 68717, a Default Order against Respondent David Lee McMillan who did not request a hearing.

On June 5, 2006, by Procedural Order, a pre-hearing conference was scheduled on June 22, 2006.

On June 22, 2006, Respondent and the Division appeared with counsel. The parties indicated that they are attempting to resolve the issues raised in the Notice to reach a settlement in this proceeding and requested that another pre-hearing conference be scheduled.

On June 23, 2006, by Procedural Order, a pre-hearing conference was scheduled for August 29, 2006.

On August 8, 2006, another attorney entered an appearance on behalf of Mrs. McMillan and

1 requested a continuance of the pre-hearing scheduled for August 29, 2006, due to a scheduling
2 conflict.

3 On August 9, 2006, the Division filed a response which indicates that it has no objection to
4 the request for a continuance so long as new counsel files an Answer to the Notice within 10 days.

5 Accordingly, the pre-hearing should be continued and Mrs. McMillan should file an Answer.

6 IT IS THEREFORE ORDERED that the **pre-hearing conference** shall be continued from
7 August 29, 2006, to **September 21, 2006, at 9:30 a.m.** at the Commission's offices, 1200 West
8 Washington Street, Phoenix, Arizona.

9 IT IS FURTHER ORDERED that an Answer shall be filed for Respondent Polly P. McMillan
10 within 10 days of the date of this Procedural Order.


