



Dear Sir/Madam:

Pursuant to A.R.S. §40-367, enclosed and filed on behalf of SSVEC  
is the Agreement.

EuroFresh Inc., formerly Bonita Nurseries, Inc., owns and operates a  
120-acre greenhouse north of Willcox. They produce excellent tomatoes  
for domestic use. The facility is currently served by SSVEC under a  
contract power agreement under SSVEC's Schedule CP rate and approved  
by this Commission in Decision No. 60446.

EuroFresh is planning to expand its operations in various ways over  
the next six to ten years. This Agreement provides revenues in excess of  
costs for SSVEC and was renegotiated at the request of EuroFresh to  
accommodate that planned growth.

As the contract contains the Parties' proprietary information, we  
request that the Commission keep the terms confidential. The term is for  
ten years. In the event SSVEC's service territory is opened to electric  
competition, EuroFresh has the right to terminate the Agreement upon  
notice to SSVEC and payment of certain costs accrued by SSVEC.
