PROCEDURAL ORDER

**BY THE COMMISSION:**

By Procedural Order issued December 3, 2002 in the above-captioned Docket No. E-01032C-00-0751, the procedural schedule was suspended at the request of the Applicant, Citizens Communications Company, Arizona Electric Division ("Citizens Electric"), and a procedural conference was scheduled for January 15, 2003.

1 By separate Procedural Order issued December 3, 2002 in the above-captioned Docket No. G-  
2 01032A-02-0598, the procedural schedule was suspended at the request of the Applicant, Citizens  
3 Communications Company, Arizona Gas Division ("Citizens Gas"), and a procedural conference was  
4 scheduled for January 15, 2003. By Procedural Order issued December 18, 2002, a procedural  
5 conference was scheduled for January 10, 2003 to address a discovery dispute between Citizens Gas  
6 and the Residential Utility Consumer Office ("RUCO") regarding the terms of a Protective  
7 Agreement to allow RUCO access to allegedly confidential materials.

8 On December 18, 2002, a Joint Application was filed by UniSource Energy Corporation and  
9 its subsidiary Tucson Electric Power Company (collectively "UniSource") and Citizens  
10 Communications Company ("Citizens") in the above-captioned Docket Nos. E-01933A-02-0914, E-  
11 01032C-02-0914, and G-01032A-02-0914, for approval of sale of the assets of Citizens Electric and  
12 Citizens Gas to UniSource, and other related matters.

13 Due to scheduling conflicts, the above-referenced procedural conferences scheduled for  
14 January 10 and January 15, 2003 shall be rescheduled for January 17, 2003, at 10:00 a.m., at the  
15 offices of the Commission. The UniSource/Citizens Joint Application docket shall also be scheduled  
16 for a consolidated procedural conference at the same time and place.

17 IT IS THEREFORE ORDERED that the procedural conferences previously scheduled for  
18 January 10 and January 15, 2003 in the above-captioned Citizens Electric and Citizens Gas dockets  
19 shall be rescheduled for January 17, 2003, at 10:00 a.m., at the offices of the Commission. The  
20 UniSource/Citizens Joint Application docket shall also be scheduled for a consolidated procedural  
21 conference on January 17, 2003, at 10:00 a.m., at the offices of the Commission.


