APPLICATION OF TOWN OF YOUNGTOWN FOR LEAVE TO INTERVENE

I.

Pursuant to A.A.C. R14-3-105, the Town of Youngtown, Arizona ("Youngtown" or "Town"), by and through its undersigned counsel, respectfully applies to the Hearing Division of the Arizona Corporation Commission ("Commission") for an Order granting Youngtown leave to intervene in the above-captioned matter regarding Arizona-American Water Company, Inc.'s ("Arizona-American" or "Company") application for an accounting order authorizing the deferral of costs associated with the Company's newly amended Sewer Treatment and Transportation Services Agreement with the City of Tolleson ("Tolleson Agreement").

II.

Youngtown and its residents will be directly and substantially affected by any Order or Decision of the Commission regarding the Tolleson Agreement because Youngtown receives sewer service from Arizona-American's Sun City Wastewater District and all of the Company's current wastewater collections from its Sun City Wastewater District are treated at the Tolleson Waste Water Treatment Plant ("Tolleson WWTP"), which is the subject of the Tolleson Agreement. The Commission has already granted Youngtown intervenor status in the Company's Sun City Water and Wastewater Districts rate case (Docket No.WS-01303A-02-0868) pending before the Commission. The Tolleson WWTP is an issue in this rate case.

III.

The participation of Youngtown in this matter will not unduly broaden the issues to be presented by Arizona-American, Sun City Water and Wastewater Districts.


