PROCEDURAL ORDER

BY THE COMMISSION:

On June 21, 2005, the Arizona Corporation Commission ("Commission") issued Decision No. 67941 which adopted the new Federal Communications Commission's guidelines on addressing changes to the Lifeline and Link-up programs in Arizona for all Eligible Telecommunications Carriers with conditions.

On June 10, 2006, Arizona Local Exchange Carriers Association Members requested a 30-day extension of time to file the report required in Decision No. 67941 regarding the outreach program.

On June 23, 2006, the Commission's Utilities Division Staff ("Staff") filed a memorandum recommending approval of the request.

IT IS THEREFORE ORDERED that the Arizona Local Exchange Carriers Association Members shall file the report regarding their outreach program on or before July 21, 2006.
