**STAFF REQUEST TO MODIFY PROCEDURAL SCHEDULE**

Staff respectfully requests that the procedural schedule be modified due to Perkins Mountain Utility Company's and Perkins Mountain Water Company's (collectively, "the Companies" or "Applicants") failure to respond promptly to all of Staff's data requests. Specifically, Perkins has failed to respond to Staff Data Requests 1.16, 1.17, 1.18 and 1.23 in a timely manner.

On March 31, 2006, Staff filed its first set of Data Requests to the Companies. Although the Companies have provided certain responses in a timely manner, other responses were not sent in to Staff until June 21, 2006. Staff needs additional time to review the responses as a whole and make sure that the most recent responses by the Companies provide Staff with the information it was seeking. Once Staff has had all of its questions adequately answered by the Companies, Staff can prepare its Addendum to the Staff Report.

Staff respectfully requests an extension of the procedural schedule by 60 days. Staff requests that its Addendum to Staff Report be due 60 days after all of Staff's data requests have been adequately answered. Staff would request that all corresponding deadlines, including the July 31, 2006 date for the hearing, be extended an additional 60 days after all of Staff's data requests have been adequately answered. Staff will file a request for a Procedural Schedule once all of its data requests have been adequately answered by the Companies. Staff believes the request is appropriate

1 given the Company's delay in providing Staff with the information it needs to prepare the Addendum  
2 to the Staff Report.
