PROCEDURAL ORDER

BY THE COMMISSION:

12 On March 20, 2003, Palo Verde Utilities Company and Santa Cruz Water Company
13 (“Applicants”) jointly filed an application in the respective, above-captioned dockets seeking to
14 extend their Certificates of Convenience and Necessity (“CC&N”) to various specified areas of Pinal
15 County, Arizona.

16 On April 2, 2003, the Commission’s Utilities Division Staff (“Staff”) docketed separate
17 intervention requests that had been faxed to Staff by Kent A. Hogan and Brent A. Butcher. Mr.
18 Hogan and Mr. Butcher state that they have been attempting to obtain water and wastewater service
19 for certain property they own in the Town of Maricopa, and they would like to be included in the
20 Applicants’ requested CC&N extension area.

21 To date, no opposition to the intervention requests has been received.

22 IT IS THEREFORE ORDERED that the requests to intervene by Kent A. Hogan and Brent D.
23 Butcher are hereby granted.


