Filing of WIFA Financing Document's, Calculation of Revenue Requirement for Principal and Interest Obligation, and Arsenic Removal Surcharge Tariff. This letter is to inform you that Yuma County Environmental Health Department will not be able to conduct the review for Arizona Department of Environmental Quality. Originally I was told that Yuma County Environmental Health Department was able to do a review in 10 working days and obtain ADEQ Approval to Construct at that time.

As the documents were submitted for review to County Environmental Health Department, I was informed that even though County Environmental Health Department conducts reviews on behalf of ADEQ, they are not authorized to conduct reviews on Water Treatment Plants (specifically). It will be required that the review be conducted by ADEQ Engineering Review Desk. Due to the need of ADEQ Engineering Review Desk reviewing the submittal, it is now anticipated to take approximately four months before an Approval to Construct is obtained.
