**SUPPLEMENTAL NOTICE OF
FILING FEBRUARY MONTHLY
STATUS REPORT IN COMPLIANCE
WITH DECISION NO. 66394**

15 On February 2, 2004, Palo Verde Utilities Company, LLC and Santa Cruz Water
16 Company, LLC ("Utilities") submitted a Monthly Status Report ("Report") for February
17 2004. The Utilities make this supplemental filing to address Staff's concern that the
18 original February Report did not contain information required by Decision No. 66394
19 (October 6, 2003).


20 On January 23, 2004, Arizona Corporation Commission Staff ("Staff") filed a copy
21 of an opinion by the Oregon Appellate Court in which Mr. Reinbold is an appellant/cross-
22 appellant. Undersigned counsel never received a copy of this Staff filing and was
23 unaware of the issuance of the opinion. The Utilities' primary management contact, Ms.
24 Cindy Liles, was likewise unaware of the filing by Staff or the issuance of the Court's
25 written opinion prior to the February 2, 2004 Report filing. Had Ms. Liles and
26 undersigned counsel been aware of the issuance of the Opinion, the February 2004 Report

1 would have made reference to the matter. Nevertheless, the issue of Mr. Reinbold's
2 ancillary court proceedings is now moot.

3 Mr. Reinbold officially resigned as President of both Palo Verde Utilities and Santa
4 Cruz Water Company effective January 30, 2004. Copies of the resignation letters are
5 attached hereto as Exhibit 1. These resignations were made in conjunction with the recent
6 acquisition of 100% of the Utilities' membership interests by Global Water Resources
7 LLC ("Global"), concluded on February 2, 2004. Consequently, Mr. Reinbold no longer
8 retains any interest in the Utilities or in any entity that has an ownership interest in Global.
9 As a result, the Utilities will soon seek to modify Decision No. 66394 to delete those
10 conditions imposed due to the Commission's concern over Mr. Reinbold's legal problems
11 in Oregon.




