PROCEDURAL ORDER

9 **BY THE COMMISSION:**

10 In Decision No. 64282 (December 28, 2001), the Arizona Corporation Commission
11 ("Commission") approved a rate increase for Arizona Water Company's ("Arizona Water" or
12 "Company") Northern Division systems of approximately 16 percent. In that Decision, the
13 Commission also ordered that this docket would remain open for an additional 180 days to allow the
14 parties to develop a proposed procedure for the recovery of costs relating to arsenic treatment and to
15 address the issue of rate consolidation of the Company's systems.

16 By Procedural Order issued June 17, 2002, the time period for completing the current phase of
17 this docket was extended by an additional 180 days from June 27, 2002, in order to allow completion
18 of the issues deferred by Decision No. 64282. The Procedural Order also scheduled a pre-hearing
19 conference for July 8, 2002.

20 On July 5, 2002, Arizona Water filed a Motion to Vacate and Reschedule the Pre-Hearing
21 Conference. The Company states that its counsel has an unavoidable schedule conflict on that date.
22 Arizona Water requests that the pre-hearing conference be rescheduled for July 16, 2002. The
23 Company represents that Staff agrees with the rescheduling request and that the Residential Utility
24 Consumer Office takes no position on the request.


