19 recovery of leasing costs and other expenses under the arsenic cost recovery mechanism
20 being considered in Phase 2 of this proceeding. The current deadline for the completion
21 of any settlement discussions is May 30, 2003. Arizona Water asks that this deadline be
22 extended through and including June 9, 2003, to allow the parties additional time to
23 explore settlement. The other deadlines set forth in the Procedural Order, dated April 25,
24 2003, would not change.
