

Qwest Corporation ("Qwest" or "Company") has received Staff's Response to Qwest's Motion for Reconsideration of Procedural Order and Motion for Protective Order ("Motion"). Qwest respectfully submits that the Company has refrained from providing information pursuant to the May 14, 2003 Procedural Order because the Company's request for an expedited review of these consolidated Motions is still pending. Therefore, Qwest has not submitted information that would otherwise expand the scope of this proceeding before the Arizona Corporation Commission ("Commission") until final resolution of this issue. As more fully set forth in Qwest's Motion, the Procedural Order expands the scope of issues to include rate comparison information that has no relevance to the underlying complaint. Further, the Procedural Order unduly expands the time for discovery. Qwest respectfully requests that the Commission's Hearing Division act upon and rule on the Company's pending Motions for Reconsideration and

1 issue a Protective Order to provide guidance to Commission Staff, Intervenors and Qwest on how
2 this outstanding issue may be resolved.


