PROCEDURAL ORDER

1 **BY THE COMMISSION:**

2 On July 9 and July 11, 2002, Troy and Tracy Denton, April and Bryant Peters, John H. and
3 Patricia J. Martin, Susan Bernstein, Tommy L. White, Sandra Rodr, Kirk and Bobbi Limburg, Arnold
4 and Tamara Fatheree, and Ernie and Sherry Thompson (hereinafter "Complainants") filed various
5 Complaints against Qwest Corporation ("Qwest") that basically stated the Complainants wished to
6 receive phone service. Qwest has refused to provide telephone service to the Complainants based on
7 Qwest's claims that the Complainants are not located within Qwest's service territory.¹

8 On January 22, 2003, Qwest filed a Motion to Stay the Proceedings until the resolution of an
9 application of Midvale Telephone Exchange, Inc. ("Midvale") to serve the Complainants' area.


10 On January 30, 2003, the Arizona Corporation Commission ("Commission") issued a
11 Procedural Order that, among other things, ordered the Complainants and the Utilities Division Staff
12 ("Staff") to file a response to Qwest's Motion on or before February 10, 2003.

13 On February 10, 2003, Staff filed a response to Qwest's Motion to Stay Further Proceedings.
14 In its response, Staff did not object to Qwest's Motion to Stay this matter until a final resolution is
15 rendered in Midvale's application. However, Staff requested that a Procedural Conference be held in
16 order to discuss the ramifications of the Motion with all parties.

17 Accordingly, a Procedural Conference should be held in order to discuss the impact on the
18 Complainants of Qwest's Motion and Staff's response.

19 IT IS THEREFORE ORDERED that this matter shall be set for a Procedural Conference on
20 March 3, 2003 at 10:00 a.m. at the Commission's offices at 1200 West Washington Street, Phoenix,
21 Arizona.


