

Mr. McNeil:

Enclosed please find an original and thirteen copies of tariff sheet revisions to SBC Telecom, Inc.'s (SBCT) Local Exchange Service Tariff, ACC Tariff No. 1.

This filing adds a ninety-day promotion in Section 10. Under the promotion, SBCT will provide a one-time credit on a subscriber's monthly bill for every referral customer who takes service with SBCT. The referral customer must be located in SBCT's serving area, and the original subscriber must have satisfactory creditworthiness with SBCT. The promotion will commence on November 7, 2003 and end on February 5, 2004.
