

**SULPHUR SPRINGS VALLEY ELECTRIC COOPERATIVE, INC.'S  
RESPONSE TO THE APPLICATION OF PHELPS DODGE, ASARCO  
AND AECC FOR THE SCHEDULING OF THE DISTRIBUTION

20 Application of Phelps Dodge, ASARCO and Arizonans for Electric Choice and Competition
