

1 Arizona Corporation Commission Staff (Staff) hereby requests that the Hearing Division take
2 official notice of the Arizona Court of Appeals' opinion regarding the Commission's Electric
3 Competition Rules, filed January 27, 2004. See Phelps Dodge Corp. v. Ariz. Elec. Power
4 Cooperative, No. 1 CA-CV 01-0068, 2004 WL 117253 (Ariz.Ct.App. Jan 27, 2004). The opinion
5 may impact these proceedings directly because it addresses matters related to them. Because the
6 opinion has only recently been issued, it is too soon to know whether review will be sought by any
7 party, including the Commission. If review is sought and granted, the results of the case may
8 change. For all these reasons, Staff requests that the Hearing Division take notice of the opinion and
9 the fact that there may be future judicial proceedings related to it. In light of these circumstances,
10 Staff requests that these dockets continue to be stayed.


