
The Project is very well located from a land use and development standpoint. The Project is close to a major existing transmission line and has ready physical access from Interstate 10 along Avenue 75E. It will provide significant economic and tax benefits to the County and the switchyard interconnection to the existing transmission line will afford electrical distribution benefits which don't currently exist to the eastern portion of the County. Finally, we have been very impressed with the attitude of Allegheny

1 and its open policy of working with the County and nearby communities.

2 The County urges the Siting Committee and the Arizona Corporation
