PROCEDURAL ORDER

BY THE COMMISSION:

On August 22, 2005, Vanco Direct USA, L.L.C. ("Vanco") filed an application with the Arizona Corporation Commission ("Commission") for a Certificate of Convenience and Necessity to provide resold long distance telecommunications services and resold local exchange telecommunications services in the State of Arizona.

On August 29, 2005, the Commission's Utilities Division ("Staff") sent a set of data requests to Vanco. There have been no filings since that time. Accordingly, Staff should make a filing updating the Commission on the status of this matter and indicate whether the matter should be administratively closed.

IT IS THEREFORE ORDERED that Staff shall file an update on Vanco Direct USA, L.L.C.'s application with any appropriate recommendation no later than September 29, 2006.
