**FIRST
PROCEDURAL ORDER**

BY THE COMMISSION:

On October 3, 2006, the Securities Division ("Division") of the Arizona Corporation Commission ("Commission") filed a Notice of Opportunity of Hearing ("Notice") against Edward A. and Maureen H. Purvis, husband and wife, Gregg L. and Allison A. Wolfe, husband and wife, Nakami Chi Group Ministries International aka NCGMI ("NCGMI"), James W. Keaton, Jr. and Jennifer Keaaton, husband and wife, and ACI Holdings, Inc. ("ACI"), (collectively "Respondents"), in which the Division alleged multiple violations of the Arizona Securities Act ("Act") in connection

1 with the offer and sale of stock and investment contracts.

2 Respondents were duly served with copies of the Notice.

3 On October 11, 2006, Edward A. and Maureen H. Purvis filed a request for a hearing.

4 On October 16, 2006, James W. Keaton, Jr., Jennifer Keaton and ACI filed a request for a
5 hearing.

6 No request for hearing has been filed on behalf of NCGMI.

7 Accordingly, a pre-hearing conference should be scheduled.

8 IT IS THEREFORE ORDERED that a **pre-hearing conference** shall be held on **November**
9 **16, 2006, at 2:30 p.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix,
