On June 27, 2006, the Arizona Corporation Commission (the "Commission") issued Decision No. 68799. As part of the last ordering paragraph of the decision, there was a requirement that Commission Staff file a report regarding Tucson Electric Power's ("TEP") request for an extension of time for its authority to construct facilities granted in Decision No. 59221 no later than September 29, 2006. Recent developments have made this deadline exceedingly difficult to meet. Staff member Jerry Smith, who would be preparing this report, has been performing numerous, time consuming work projects. Further, Mr. Smith has been unavailable for a large span of time on extended medical leave. Combined, these factors make the September 29, 2006 deadline impracticable for Staff.

Staff requests extension of the deadline for filing the report on TEP's request for extension of time for its authority to construct facilities to October 13, 2006.
