**BY THE COMMISSION:**

On July 28, 2006, the Arizona Corporation Commission ("Commission") issued Decision No. 68858 in this docket. Decision No. 68858 ordered Arizona-American Water Company ("Company") to file with the Commission revised schedules of rates and charges consistent with the schedule set forth in the Decision on pages 41 through 44, and consistent with the discussion in the Decision.

On August 4, 2006, the Company filed a Notice of Filing Revised Tariffs in compliance with Decision No. 68858.

On August 25, 2006, the Company filed another Notice of Filing Revised Tariffs, stating that the purpose of the filing was to correct an error in Decision No. 68858.

On September 7, 2006, the Commission's Utilities Division Staff ("Staff") filed a Motion for Nunc Pro Tunc Entry. In its Motion, Staff submitted the following as nunc pro tunc entries:
