**PROCEDURAL ORDER**

10 **BY THE COMMISSION:**

11 On September 5, 2006, the Securities Division ("Division") of the Arizona Corporation  
12 Commission ("Commission") filed a Notice of Opportunity of Hearing ("Notice") against Trend  
13 Management Group, Inc. ("TMG"), Scott Renny Bogue and Arlene Jane Bogue, husband and wife,  
14 Ryan James Herndon and Lori Darlene Herndon aka Lori Herndon aka Lori Jordan, husband and  
15 wife, Trend Capital, L.L.C. ("TCL"), Linda Bryant Jordan aka Linda Van Vranken aka Linda Jordan-  
16 Van Vranken, a married woman, individually, and dba The Trend Group, Inc., Russell Langdon Van  
17 Vranken, husband of Linda Bryant Jordan, Easy Street Financial Group, Inc. ("Easy Street"),  
18 Christopher Ellis Marx and Jane Doe Marx, husband and wife, and Scot Alan Oglesby and Lori Ann  
19 Oglesby, husband and wife, (collectively "Respondents"), in which the Division alleged multiple  
20 violations of the Arizona Securities Act ("Act") in connection with the offer and sale of stock,  
21 investment contracts, participation in profit-sharing arrangements, and/or evidences of indebtedness.

22 Respondents were duly served with copies of the Notice.

23 On September 12, 2006, Ryan Herndon and TCL filed a request for a hearing.

24 On September 15, 2006, TMG, Scott Bogue, Arlene Bogue, Ryan Herndon, TCL, Lori  
25 Herndon, Linda Bryant Jordan-Van Vranken, and Christopher Ellis Marx filed requests for a hearing.

26 On September 26, 2006, by Procedural Order, a pre-hearing conference was scheduled for  
27 November 2, 2006.

28 On October 2, 2006, Russell Van Vranken filed a request for hearing.

No request for hearing has been filed on behalf of Easy Street.

Accordingly, the pre-hearing conference will take place as scheduled.

2 **2, 2006, at 9:30 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona.


