PROCEDURAL ORDER

BY THE COMMISSION:

On November 4, 2005, the Arizona Public Service Company ("APS") filed an application with the Arizona Corporation Commission ("Commission") for a rate increase and to amend Decision No. 67744 (April 7, 2005).

On November 9, 2005, the Commission opened a docket to investigate the unplanned outages during 2005 at the Palo Verde Nuclear Power Generating Station. The Commission also opened a docket to audit the fuel and purchased power practices and costs of APS.

On April 5, 2006, by Procedural Order, a hearing was scheduled and deadlines were established.

On August 17, 2006, Staff of the Commission filed Motions to Consolidate ("Motions") the

1 above-captioned matters.

2 By Procedural Order issued September 18, 2006, the above-referenced matters were
3 consolidated.

4 On September 27, 2006, Staff filed a Motion to Extend the time in which to file the
5 surrebuttal testimony of two Staff witnesses, William Jacobs and James Daniel. The surrebuttal
6 testimony of these witnesses was scheduled to be filed on or before September 27, 2006, and Staff
7 requested that their testimony be filed on or before October 13, 2006. Staff indicated that they would
8 have no objection to giving the Company additional time to file its rejoinder testimony. Staff further
9 stated that counsel for Staff had communicated the contents of the motion to counsel for APS, who
10 does not oppose the Motion.

11 IT IS THEREFORE ORDERED that Staff shall file the **surrebuttal testimony of William
12 Jacobs and James Daniel no later than 4:00 p.m. on October 13, 2006.**

13 IT IS FURTHER ORDERED that the date for filing Arizona Public Service Company's
14 corresponding rejoinder testimony will be determined at the October 5, 2006, pre-hearing conference.

15 IT IS FURTHER ORDERED that all other deadlines established in the April 5, 2006
16 Procedural Order shall remain the same.
