Staff proposes the attached amendment in order to clarify the method of compliance for the submittal of "Approvals to Construct" and "Certificates of Assured Water Supply" issued by the Arizona Department of Environmental Quality and Arizona Department of Water Resources, respectively. Although the Recommended Opinion and Order accurately reflects the compliance methods recommended by Staff, Staff believes that its proposed amendment clarifies its recommendations, while keeping their original intent but making the tracking of the pertinent compliance issues easier for Staff.


