Dear Mrs. Jaress:

Per your request I am re-emphasizing Vista Montana Subdivision's need for water and wastewater service in Scenic, AZ to be provided by Sunrise Utilities. As the process in obtaining a CC&N took significantly longer than anticipated our approved sketch plan for Mesquite Heights, issued by Mohave County July 16, 2004, had expired, initiating a complete resubmittal. The project was then renamed Vista Montana, to comply with Mohave County's regulations, and resubmitted Nov. 4, 2005. On Feb. 28, 2006 our sketch plan was approved and a new tract number was issued. Our preliminary plat is currently in review with Mohave County and we are currently awaiting approval. This preliminary plat is essential in determining the number of lots in the subdivision and thus the subdivisions' water demand. Upon receiving preliminary plat approval our water adequacy report submittal to ADWR will commence. We anticipate the Mohave County approval process taking 4 months. The submission to ADWR will follow thereafter with approval to construct expected to follow in the subsequent 6 months.

We would appreciate an extension of Sunrise Utilities' CC&N in order to better serve the community and to help create a neighborhood community environment of which we may all be proud. If you have any questions or concerns please feel free to contact me at (702) 346-6195.
